## SEAA Bylaws

### Section 2. Nomination by Petition

Nominations for directors may be made, endorsed with the names of not less than ten (10) members of the Association, and mailed to the Association Executive Director so as to be received not less than ninety (90) days before the date of the Annual Meeting of Members (Annual meeting slated for: 03/10/2012) and the Association Executive Director shall incorporate the names of the candidates so nominated, designating them as "Nominated by Petition," on the ballot or ballots to be mailed as provided hereinafter in Article V, Section 3.

The members nominating candidates by petition shall certify on the petition that they have secured the prior acceptance, in writing, of the candidate so nominated.

In accordance to the SEAA Bylaws you may submit a nomination by petition for the SEAA Board of Directors election in 2012, please complete and submit this form. The form must be accompanied by signatures from a minimum of 10 (ten) SEAA Members who are eligible to vote.

SEAA members who are nominated by petition will automatically be eligible to stand for election in 2012.
